You will find exercises included in the text. Some of these are to help you to think through the reading activity material. It will be useful if you complete the exercises using words or phrases which are your own. Other exercises are to help you think about and evaluate your own situation and to apply what you are learning to that situation. Space is provided in the work book for your written answers.

How long you take to study this module will depend on factors such as your background training, experience, how quickly you read, your study situation, etc. The length of time you take should be the time you need to study effectively and complete all learning exercises and activities.
